PORTS AND AIRPORTS DEVELOPMENT LEVY ACT, No. 18 OF 2011

Order under Section 3

BY virtue of powers vested in me by Sub-section (3) of Section 3 of the Ports and Airports Development Levy Act, No. 18 of 2011, I, Mangala Samaraweera, Minister of Finance and Mass Media do hereby this Order, amend the Extraordinary Gazette Notification No. 2049/16 of 13.12.2017 by,

1. The addition of the following Sub Paragraph immediately after Sub Paragraph (b) of Paragraph 1:-
 - (c) “Ports and Airports Development Levy shall be charged and levied on importation of each article specified in Column III corresponding to the H. S. Headings in Column I and H. S. Codes in Column II of the Schedule III hereto, a concessionary rate of 2.5% in its corresponding entry in Column IV, on the recommendation of the Secretary, Ministry of Industry and Commerce based on a set of predetermined criteria.”
2. The addition of Schedule here to as Schedule III, immediately after the Schedule II of the said Extraordinary Gazette Notification No. 2049/16.
