2. Steps to Voluntary reactivation of Value Added Tax (VAT)

Step 01	Visit the IRD website www.ird.gov.lk
Step 02	Click on the e-Services tab and then Access to e-Services.
Step 03	Proceed to login as Individual/Partnership/Corporate Taxpayer.
Step 04	Select TIN as your tax reference number and enter your TIN number, PIN/SSID and the text (CAPTCHA) given on the left, and click Login.
Step 05	Click on the Taxpayer Registration tab and select Change Tax type Request.
Step 06	Click on the tax type (VAT), change its status to ACTIVE and save.
Step 07	Upload the request letter and supporting documents, if any
Step 08	Click Next, fill in declaration section and submit
