**SPECIAL COMMODITY LEVY ACT, No. 48 OF 2007**

**Order under Section 2**

BY virtue of the powers vested in me under Section 2 of the Special Commodity Levy Act, No. 48 of 2007, I, Mahinda Rajapaksa, Minister of Finance and Economic Affairs of the Democratic Socialist Republic of Sri Lanka, do by this order impose in respect of list of the commodities specified in Column I of the Schedule hereto a Special Commodity Levy, at the rates specified in the corresponding entries in Column II of that Schedule.

This Order shall be valid for a period of 03 months commencing from November 02, 2018, subject to provisions of Sub section (3) of Section 2 of the Special Commodity Levy Act, No. 48 of 2007.

The Orders made under Section 2 of the Special Commodity Levy Act, No. 48 of 2007 and published in the *Extraordinary Gazette Notification* No. 2075/31 of 14.06.2018 in respect of Black gram classifiable under the HS Code 0713.31.29 and *Gazette Notification* No. 2070/6 of 09.05.2018 in respect of lentils classifiable under the HS Codes 0713.40.11, 0713.40.12, 0713.40.21, 0713.40.22 and *Gazette Notification* No. 2087/76 of 07.09.2018 in respect of Chickpeas classifiable under the HS Codes 0713.20.10, 0713.20.20 are rescinded with effect from November 02, 2018.
